Reason:

Profit after corporate income tax in the fourth quarter of 2024 reached VND 12.8 billion, down VND 3.3 billion, equivalent to a decrease of 20% compared to the same period last year due to corporate income tax payable of VND 4.9 billion. Profit before corporate income tax in the fourth quarter, 2024 increased by 10%, equivalent to VND 1.6 billion compared to the same period last year (In the fourth quarter, 2023, the Company did not have to pay corporate income tax due to accumulated losses). The Company's profit after corporate income tax in 2024 was VND 54.8 billion, up VND 8.6 billion, equivalent to 19% compared to the same period last year. Profit after tax in 2024 increased by 24% compared to the plan. With the achieved profit in 2024, the Company has eliminated all accumulated losses..

In 2024, NCS's production and business activities received more positive signals of recovery than in 2023. Some airlines resumed operations earlier than expected, while others quickly completed sales promotions to improve quality on some key routes. The Company's output and revenue indicators achieved good growth. On the other hand, good cost control in operations also contributed to improving the Company's production and business efficiency. For the nonair sector: The Company continues to implement activities to build, develop and position the brand.
